- The committee briefly reviewed previous minutes advising to the new members that the review came due to the Plans of Management which included 1500 comments. 50% touched on dogs not strongly for or against, evenly split. Council decided that it needed to look at changing controls and expand areas.

Subject: NEW BUSINESS

THAT the committee:

• Provide an update on the REF following the Palm Beach Case

- Next progression of findings is the Council report, however, delayed due to the Northern Beaches and Shoalhaven Court cases
- o In both cases, environmental protection groups took each Council to Court, based on proposals to allow dogs to be off leash in areas considered environmentally sensitive— Court did not rule on if dogs should or should not be allowed in these areas, but it ruled on the process undertaken and if Council took due diligence
- Council must take into account environmental factors under Part 5 of the Environmental Planning and Assessment Act. It does not trigger a DA but change in activity in dog activity is considered a "change in activity" which can be approved if you have undertaken a review of environmental factors which includes natural environment, traffic impact, noise impact, cleanliness, parking impacts etc.
- Legal advice has been received

 for every proposed change (currently 18 proposed changes) a Review of Environmental Factors (REF) needs to be completed. REFs will be conducted by independent consultants
- Changes made in the past are considered done no environmental activity needed
- REF then to be approved by the delegated authority Director of Planning and Place, Scott Pedder
- Director of Planning and Place has decided to have all REFs prepared and then report to Council

Review pet focused activities for 2024/2025 and review those of 2023

- Roger Faulkner reported that previous events were a success however, his team only manage the bookings. Rotary clubs tend to organise the events
- Provide suggestions for managing animal waste
 - Only suggestion made was for increased campaigns for awareness

Provide an update on animal registration

- Colin asked for clarification on what specifically was required, however no response received. Cr Jarvis has asked in the next meeting for an update on number of dogs and cats registered in LGA
- Discuss reports and advisings on foxes, rats and cats
 - Rats are considered vermin and not regulated or controlled by Council
 - Foxes are considered a non-native pest and managed by Department of Primary Industries
