Council will consider the application but may resolve to grant or not to grant a Lease or Licence at its discretion. Council will only consider granting a Lease or Licence to the owner of the property immediately adjacent to that portion of roadway.

- 1) Council's application and processing fees must accompany the application.
- 2) A Lease or Licence will be subject to a market rent. This rent will be determined by an independent Valuer.
- 3) Prior to the issue of a Lease or Licence, the applicant must pay Council's valuation and legal costs, including any Stamp Duty incurred in granting the Lease/Licence.
- 4) Prior to the issue of a Lease or Licence, the applicant must obtain a Public Risk Insurance Policy in the amount of twenty million dollars (\$20,000,000) or other such amount as the Council may require from time to time against any action that may arise from damage to property or injury to any person using the footway. Council must be nominated as an 'Interested Party' on the policy and indemnified against any claim.
- 5) The issue of a Lease / Licence will be in accordance with Council's Policy and Procedures for Leasing & Licensing of Council Controlled land, and in respect of a classified (main) road will be subject to the concurrence of Transport for NSW (TfNSW).
