Woollahra Council does not charge any fee for the registration of a health premises, however a valid development consent is required. Health Premises inspection fees are payable as and when inspections are carried out by Council's Food & Health Officer.

The inspection fee charge is \$108.70 for an inspection up to 30 minutes (including travelling) and \$208 per hour or part hour for any inspection over 30 minutes (including travelling).
